#### BUSINESS

Conversation included:

- If a lower price can be received for the same quote it would best benefit HHA; financially versus procedural.
- Overriding our own process for a good cause. Substance over Process. Legal counsel provided legal guidance and led the motion to offer Salerno Brokerage the opportunity to provide insurance quotes for Town of Huntington Housing Authority.
